

CHECK LIST OF DOCUMENTS NEEDED FOR EDUCATION ASSISTANTS (EA) & GENERAL SCHOOL ASSISTANTS (GSA)

PREPARATION, BETWEEN NOW AND DECEMBER 2022:

- Go to your nearest Police station to apply for a SAPS PCR - Police Clearance Report (see the process below*)
- Once you receive the SAPS PCR, proceed to apply for vetting on the NRSO (see the process below**)

AT INTERVIEWS AT THE SCHOOLS you need to submit the following:

- 1. Certified copy of ID / passport
 - 2. CV
 - 3. Testimonial (from former school, local chief, church leader etc)
 - 4. Copy of your NQF level 4 or higher qualification certificate (this is NOT required for GSA positions) but recommended for EA roles
- See below what you need to submit once you are appointed **and start applying for these documents so long to be prepared**

ONCE NOTIFIED THAT YOU HAVE BEEN APPOINTED you need to submit the following additional documents:

- 5. **SAPS PCR** (Police Clearance Report) to the school where you are appointed.
The SAPS PCR is a Fingerprint report (see * on how to apply for this at your nearest Police station)
- 6. **Certificate** from the Department of Justice to confirm that you are NOT on the **National Register for Sexual Offenders (NRSO)**
See below at ** what you need to do to apply for this at the Department of Justice
- 7. **Principal will give you the ACCEPTANCE AND DECLARATION FORM for signing**
- You will sign a DECLARATION at the school where you confirm a couple of things, for e.g., you were not appointed in Phase I, II or III as a EA or GSA, you are NOT in employment, education or training, you do NOT receive a R350 SASSA grant, and you do NOT have a criminal record, but it would be best if you can submit the SAPS PCR as soon as possible as this will be required by all appointed EAs and GSAs.

BEFORE YOU START WORKING at the school, you need to:

- 8. Submit the following **3 certificates**: *(the school will invite you to the training)*
- 7.1 Certificate of completion of Online Orientation training
- 7.2 Certificate of completion of Digify Africa digital literacy module
- 7.3 Certificate of completion of the National School Safety Framework course

* HOW TO APPLY FOR THE SAPS PCR

- Go to your nearest Police station or Local Criminal Record Centre (LCRC) and complete a SAPS 91-a FINGERPRINT FORM
- Pay R75
- Collect the Police Clearance Report (PCR) within 15 days of application, but you have to take your ID / passport with for collection.

Please note that this might take longer due to the number of applicants applying for this nationally

Make two copies of the report once you receive it and hand the one copy in at the school. Keep one copy safe. You will need to submit the original below**

** HOW TO APPLY FOR THE CERTIFICATE to proof that you are NOT on the NATIONAL REGISTER OF SEXUAL OFFENDERS (NRSO)

- Complete a J738 – FORM 7 and sign the form
- You need to give reasons for applying for a certificate. Use the following: *"I am applying for an Education / General School assistant role at my nearest school"*
- You need to attach a certified copy of your ID / passport
- You need to attach a SAPS 91-a FINGERPRINT form (see *) – attach the original SAPS PCR and remember the one copy of the PCR goes to the school
- You need to provide a full forwarding or postal address / physical address / contact number/s / email address / any contact details so that the certificate can be send to you
