Lomhlahandlela wokuthengwa kweyunifomu yesikole nezinto zokufunda uhloselwe:

Sekudlule iminyaka eminingi Competition Commission iphenye izikhalazo eziningi ezivela kubazali nakubanakekeli ezibhekiswe ezikoleni kanye nakubahlizeki beyunifomu yesikole. Abazali bakhononda ikakhulukazi ngezinto ezimbili:

1. intengo ephezulu yeyunifomu yesikole; kanye
2. nokuthi ezinye izikole ziphoqa abazali ukuthi bathenge iyunifomu nezinto ezihlobene nokufunda kumhlizeki oyedwa kuphela.



Lokhu kuziphatha kushiye abazali bengenamali ekuqaleni konyaka ngamunye wesikole futhi kubenza bazizwe bekhungathekile ngoba abatholi umhlizeki oshibhile weyunifomu yesikole.

- usize izikole, abazali kanye nama-SGB ukuqonda izinzuzo zokuncintisana ekuthengisweni kweyunifomu yesikole nezinto zokufunda;
- usize izikole ukuthi zikhuthaze ukuncintisana phakathi kwabahlizeki beyunifomu yesikole nabezinto zokufunda;
- ukhuthaze abazali ukuthi babambe iqhaza futhi basebenzise ilungelo labo lokukhetha izindleko; futhi
- ukhuthaze ama-SGB ukuthi athuthukise izinqubomgomo ezikhuthaza izindlela zokuthenga ezikhuthaza ukuncintisana.

Uma izikole, abazali nama-SGB bebambisene, bangehlisa intengo yeyunifomu yesikole nezinto zokufunda.

Kungani umncintiswano ubalulekile ekuthengeni iyunifomu yesikole nezinto zokufunda?

Lapho abahlinzeki beyunifomu yesikole nezinto zokufunda bencintisana ngamakhasimende, bahlala bekhuthazeka ukuthi bathuthukise ikhwalithi yabo futhi behlise amanani abo ukuze bakhange abathengi. Ngeshwa, umasingenzi lokho: lapho abahlinzeki bengancintisani futhi beqinisekiswa ukuthi bazothola amakhasimende esikoleni - mhlawumbe ngenxa yokuthi izidingo zeyunifomu yesikole zehlukile noma ngoba isikole sinesivumelwano esikhethekile nomhlinzeki oyedwa – ngakho baphelelwa inkuthalo yokuthuthukisa ikhwalithi noma ukuthola izindlela zokwehlisa amanani abo.

Ngokuhamba kwesikhathi, ukuncintisana kuzibonise kuyindlela ephumelelayo yokugcina abahlinzeki bethuthukisa ikhwalithi engcono kakhulu ngentengo ephansi kakhulu. Competition Commission ikhona ukuthi ithuthukise umncintiswano kule makethe futhi iqinisekise ukuthi amakhasimende ekugcineni azuza izinzuzo zomncintiswano: ikhwalithi ehamba phambili ngentengo ephansi kakhulu.

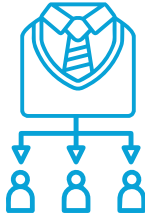

- **Sabalalisa amathuba:** izikole kufanele ziqoke noma zikhethe abahlinzeki abaningi beyunifomu yesikole ngokungokwenzeka ukuze amakhasimende akwazi ukukhetha kwabangingi;
- **Nciphisa, usebenzise kabusha futhi vuselela:** inani lezinto ezikhethekile ezivela kwiyunifomu yesikole kufanele

lilinganiselwe kokudingekile kuphela, futhi uma kungenzeka, lezinto ziphinde zisetshenziswe ukunciphisa izindleko eziphindaphindiwe nokusaphaza. Kodwa lokhu akukhuthazwa ngezikhathi ezingaqinisekile zobhubhane lweCovid-19; futhi

- **Sebenzisa ukuncintisana ngokuBhida:** uma izikole kufanele ziqoke abahlinzeki abakhethekile, kufanele bakwenze lokho ngemuva kwenqubo yokuncintisana yokubhida futhi kufanele bashintshe abahlinzeki njalo.
