## EXPLANATORY NOTES

**Learner:** Any person receiving education or obliged to receive education in terms of the South African Schools Act 84 of 1996.

Minor: Children under the age of 18 are legal minors and, accordingly, have limited legal capacity to act independently without the assistance of an adult.

Parent: In terms of the South African Schools Act 84 of 1996, a parent means;

- a. The biological or adoptive parent or legal guardian of a learner;
- b. The person legally entitled to custody of a learner or
- c. The person who undertakes to fulfil the obligations of a person referred to in (a) and (b) towards the learner's education at school.

## Section 9 of the South African Schools Act 84 of 1996:

"the governing body may, on reasonable grounds and as a precautionary measure, suspend a learner who is suspected of serious misconduct from attending school, but only enforce such suspension after the learner has been granted a reasonable opportunity to make representations to it in relation to such suspension".
