Please Note: Applications must be submitted on form NCK1 obtainable from any District Office as indicated above, which must be fully completed, originally signed, dated by the applicant and accompanied by a comprehensive Curriculum Vitae, which must include a complete chronological record of teachers training and teaching experience as well as names and telephone numbers of at least two contactable persons willing to act as referees. Where you apply for more than one post, your preference must be indicated on form NCK 4.

Original certified copies of matric certificate, diplomas, degrees, certificates and green Identification Document must be submitted with each application. It is compulsory for all potential applicants to be registered with the South African Council for Educators (SACE).

All applications, including those submitted via registered mail must reach the department before 16:00 on the day of the closing date. Incomplete applications, faxed applications, emailed applications or applications received after the closing date will be disqualified. Separate NCK1 forms and accompanying CVs must be completed for each post and candidates must quote the relevant reference number of each post and the name of the relevant publication in which the advert appeared.
